**CHANGE OF COMPANY NAME, STOCK SHORT NAME,
COMPANY LOGO AND WEBSITE**

References are made to (i) the announcement of SFQ Global Limited (formerly known as Rimbaco Group Global Limited) (the “**Company**”) dated 15 July 2026 (the “**Announcement**”); (ii) the circular of the Company dated 16 July 2026 (the “**Circular**”); and (iii) the announcement of the Company dated 4 August 2026 in relation to the poll results of the extraordinary general meeting of the Company held on 4 August 2026 (the “**EGM**”). Unless otherwise defined, capitalised terms used herein shall have the same meanings as those defined in the Announcement and the Circular.

CHANGE OF COMPANY NAME

The Board is pleased to announce that following the passing of a special resolution approving the Proposed Change of Company Name by the Shareholders at the EGM, the English name of the Company has been changed from “Rimbaco Group Global Limited” to “SFQ Global Limited”, and the Chinese name “賽孚迅國際有限公司” has been adopted and registered as the dual foreign name of the Company, both with effect from 6 August 2026 pursuant to the Certificate of Incorporation on Change of Name of the Company issued by the Registrar of Companies in the Cayman Islands on 6 August 2026 (the “**Change of Company Name**”).

The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Companies Registry in Hong Kong on 27 August 2026, confirming the registration of the Company’s new English name and new dual foreign name in Chinese, namely “SFQ Global Limited” and “賽孚迅國際有限公司” respectively, in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

CHANGE OF STOCK SHORT NAME

Following the Change of Company Name becoming effective, the stock short name of the Company for trading in the Shares on the Stock Exchange (the “**Stock Short Name**”) will be changed from “RIMBACO” to “SFQ GLOBAL” in English, and “賽孚迅國際” will be adopted as the Stock Short Name in Chinese with effect from 9:00 a.m. on 7 September 2026. The stock code of the Company on the Stock Exchange remains unchanged as “1953”.

CHANGE OF COMPANY LOGO

The Board further announces that, with effect from the date of this announcement, the Company has adopted a new logo (the “**Change of Company Logo**”) to reflect the Change of Company Name. The Company’s former and new logos are set out below:

EFFECT OF THE CHANGE OF COMPANY NAME AND THE CHANGE OF COMPANY LOGO

The Change of Company Name and the Change of Company Logo will not affect any rights of the Shareholders or the Group’s daily business operation and its financial position.

All existing share certificates of the securities of the Company in issue bearing the former name of the Company and/or the former logo of the Company will continue to be valid evidence of legal title to such securities of the Company and will continue to be valid for trading, settlement, registration and delivery purposes. Accordingly, there will not be any arrangement for free exchange of the existing share certificates for new share certificates bearing the new name of the Company and the new logo of the Company. New share certificates will be issued in the new English name and dual foreign name in Chinese of the Company and bearing the new logo of the Company with effect from 7 September 2026.

CHANGE OF COMPANY WEBSITE

The website of the Company will be changed from “www.rimbaco.com.my” to “www.sfqglobal.com” with effect from the date of this announcement.
